## 29th Annual Corporate Volleyball Tournament

Saturday, May 9th, 2020

Registration Information

The **29th Annual Corporate Volleyball Tournament** is a 6-a-side co-ed tournament to be held at **North Village CC Field** on **Saturday, May 9th, 2020**. This tournament is open to non-BVA members and is intended to introduce new people to the sport of volleyball as well as provide groups / companies with the opportunity to participate in a community event together.

Sponsors have the option of sponsoring a team for the tournament and/or **sponsoring a net**. If a net is sponsored, then the company's logo or sign (as provided by the company) will be displayed on one net and included in all tournament information, announcement, etc. Net sponsorship is \$150 per net.

The tournament will start at **9:30 a.m.** and will continue through approximately 3 p.m. Each team must consist of at least 2 men and 3 women (6 players in total). **Each team is restricted to 2 top level competitive players on the court at one time. LUNCH WITH BE PROVIDED FOR UP TO 8 PLAYERS PER TEAM.**

Team registration for this tournament must be completed on-line at [www.bva.bm](http://www.bva.bm). When completing your registration please take note of the following information:

1. Please ensure the Team Name includes the sponsor's name.
2. Registration Agreement – select accept, although the BVA will not hold you binding to this as this is a default setting in our system that is not applicable to this tournament.
3. Once the registration is submitted an invoice will be emailed to you, which must accompany the registration payment, so ensure a proper email address is provided.
4. You will then be prompted to complete a Roster online. Please enter all teammates by BVA membership number if they have one, if not, by name.
5. You will need to hand in your completed Waiver form on the tournament day.

Net sponsorship registration can also be completed on-line at [www.bva.bm](http://www.bva.bm). Please follow the same instructions as above. Someone will be in touch with you regarding logo and signage for your net.

Payments can be made by **Credit Card or by Wire Transfer** to the BVA account detailed on the invoice you will be emailed following on-line registration or via cheque or bank draft and dropped off at the Bermuda Volleyball Association mailbox at Mailboxes Unlimited on Par-la-ville Road. All cheques or bank drafts must be accompanied by the invoice that will be emailed to you following your on-line registration. Please have your invoice and fee in an envelope and mark the date and time. Fees will only be refunded, if cancellation is prior to May 9<sup>th</sup>, 2020.
